PUBLIC NOTICE IS HEREBY GIVEN that a special meeting of the Board of Directors of the Belford South Metropolitan District, Town of Parker, Douglas County, Colorado, shall be held at 10:30 a.m. on Thursday, March 26, 2020, at the offices of CliftonLarsonAllen LLP, 8390 E. Crescent Parkway, Suite 300, Greenwood Village, Colorado 80111 and by teleconference. At such meeting, it is anticipated that the Board of Directors of Belford South Metropolitan District (the “Board”) will make a final determination to issue or refund limited tax general obligation indebtedness of Belford South Metropolitan District (the “District”) comprised of its Limited Tax General Obligation Bonds Series 2020A and its Limited Tax General Obligation Bonds Series 2020B in the estimated, aggregate principal amount of \$31,000,000 (collectively, the “2020 Bonds”), to be authorized by the adoption of a parameters resolution also authorizing the execution and delivery by officers of the District of an Indenture of Trust for each such series, a Bond Purchase Agreement, a Continuing Disclosure Agreement and other necessary and related documents, approving a Post Issuance Tax Compliance Policy, authorizing the preparation and use of a Preliminary Limited Offering Memorandum and a final Limited Offering Memorandum, and delegating certain determinations with respect to the 2020 Bonds to the Board and an identified Sale Delegate.

Pursuant to the Supplemental Public Securities Act, no legal or equitable action brought with respect to any legislative acts or proceedings in connection with the authorization or issuance of such bonds may be commenced more than thirty days after the authorization of such bonds pursuant to the aforementioned resolution.

At this meeting, the Board also expects to authorize execution of all documents, instruments and certificates in connection therewith, ratify prior actions, authorize incidental actions, repeal prior inconsistent actions, address those matters set out in the agenda below as the same may be amended at the meeting, and take up such other business as may come before the Board. The meeting is open to the public, and members of the public are encouraged to participate by teleconference via the teleconference information provided below.
